Contribution rules for the day care centre

"Einsteinchen CompanyKids"

For the care of children in the company day care centre "Einsteinchen CompanyKids", the following parental contribution (consisting of care contribution, meal subsidy and hygiene flat rate) is due per child cared for (valid from: 01.01.2023):

1. childcare contribution

(I) The monthly contribution of the parents for the care (care contribution) corresponds to the prices of comparable facilities in Geesthacht; it currently amounts to:

- (II) For siblings, the childcare fee is reduced in accordance with the currently applicable provisions of the Daycare Act for the State of Schleswig-Holstein (§ 7 para. 1 p. 1 KiTaG) and taking into account any voluntary benefits/reductions offered by the town of Geesthacht.
- (III) Ask your local municipality for information on relief options. Low-income earners can apply to the local social welfare office for a subsidy towards childcare costs in accordance with § 90 Para. 3 SGB VIII.
- (IV) If, after the parents/parents have left the employment relationship with the Helmholtz Centre hereon GmbH, they still wish to have their child/children cared for in the "Einsteinchen", an agreement will be made to take over the share of the care taken over by hereon until then. In addition, parents must inquire about subsidies from their home communities. The care costs to be paid by the parents after leaving can be up to around 1,800.00 euros/month. This amount may vary depending on the amount of care provided.

2. meal allowance and hygiene flat rate

- (I) In the day care centre, the children receive a range of meals based on scientific findings for ageappropriate nutrition. The costs of 80 Euros per month are to be borne by the parents. This includes breakfast, a warm, freshly prepared lunch suitable for children, an afternoon snack, the evening meal and drinks. For children who occupy an afternoon place (care from 1 pm), the lump sum for meals is reduced to 40 euros.
- (II) For children who are breastfed or whose parents bring baby food or jars, no flat meal fee is charged. The same applies to children who have to be fed a special diet for health reasons if this diet cannot be provided at the facility.
- (III) The children receive all care and hygiene products for age-appropriate care at the facility. The cost of 6 Euros per month is to be borne by the parents. This includes toothpaste, toothbrushes, soaps, wet wipes, disinfectants, nappy-changing utensils (except nappies), creams and sunscreen.
- (IV) There is no reduction in the meal allowance and hygiene fee for siblings.

(3) Collection and due date of the parental contribution, the meal subsidy and the hygiene fee

- (I) The parental contribution, the meal subsidy and the hygiene flat rate are levied as a monthly contribution and are to be paid from the beginning of the month in which the child is admitted to the day care centre.
- (II) The monthly fee is to be paid directly to the provider of the day care centre at the beginning of each month.
- (III) The monthly fee is payable irrespective of the child's actual attendance and also for times when the day care centre is closed.
- (IV) The parental contribution, the meal subsidy and the hygiene fee must be paid by the end of the month in which the child leaves the day care centre or by the end of the notice period, if this has not yet expired at the end of the care.
